BILLING & PAYMENTS

Miss Robin's Piano Studio uses a tuition-based payment plan. This means students do not pay "by the lesson" but rather pay a set monthly tuition fee. The tuition fee is much like a membership fee and allows students (and parents) a repeating lesson time (chosen and reserved just for you), access to Miss Robin for questions, resources, registration, and participation in recitals and other events. The education experience at Miss Robin's studio goes far beyond the minutes spent in each actual face-to-face lesson, and for that reason Miss Robin has decided that a tuition system is appropriate. By paying a set monthly tuition, students and their families can feel confident that they are getting the very best education possible on their instrument while supporting their continued success as well as the success of the studio. Tuition-based payments also save hours of behind-the-scenes administrative work for Miss Robin. And the time saved is then invested back into the students whether it be spent teaching, planning, practicing, writing or furthering education.

Please read the following paragraphs to ensure you fully understand the logistics of the tuition-based payment process and the policies regarding missing a lesson. Commitment to music lessons is made at the beginning of each school year (August - May). By registering for the school year, you agree to make timely monthly tuition payments.

Each monthly installment is **due by the first lesson of each month**. By registering for a regular lesson time you are committing to pay for that time slot through the end of the school year. Day or time changes or a choice to discontinue lessons does not excuse any student from completing all monthly payments. **No refunds will be given**.

Any materials given to the student will be billed **in addition to tuition costs.** The additional costs will be added to the next month's invoice amount. Payments for invoices are due by the due date indicated on the invoice.

Holidays and breaks will be determined at the beginning of each school year and will be pre-determined by the studio. Tuition rates are thoughtfully calculated and account for holidays and breaks within the school year. Miss Robin's Studio will typically follow the **Orange County Public School** calendar. To keep abreast of studio closings, a calendar will be provided at the beginning of each school year and will also be available on both **missrobinspianostudio.com** and **MyMusicStaff** websites. Extra studio openings for make-up lessons will be noted on the calendar as well.

LATE PAYMENTS

Monthly tuition payments are due by the first lesson of each month. Other invoices are due by the date indicated on the invoice.

A late fee of 5% of the invoice total will be added to any invoices outstanding 14 days or more.

CANCELLATIONS

If a student will be absent from a lesson for any reason, the student may inform Miss Robin through email or by indicating their absence on the **MyMusicStaff** calendar. Individual lessons will not be rescheduled or refunded. Miss Robin may offer make-up lesson openings on a particular day and time of her choosing. These additional studio openings will be noted on the calendar. This is dependent on Miss Robin's schedule and availability. Make-up lessons, if offered, are offered as a courtesy and are never guaranteed. Make-up lessons are not available for "no-shows."

If Miss Robin cancels a lesson for any reason, she will designate a make-up lesson option. Refunds will not be given, but Miss Robin will do her best to offer a convenient opportunity to make-up the cancelled lesson.

If a student is unable to make a lesson, they should contact Miss Robin by text, call, or email. Individual lessons may not be rescheduled. Make-up lessons are never guaranteed. No refunds will be given.

If Miss Robin is unable to make a lesson, she will contact all students by text, call or email. No refunds will be given. In most cases, a make-up day will be arranged by Miss Robin.

Pre-designated make-up days or events may be offered at the discretion of Miss Robin but are not guaranteed. Again, please refer to the calendar for additional studio openings for make-up lessons.

"No-show" absences will not be offered a make-up day. Make-up lessons cannot be re-scheduled once registered. Make-up lessons are offered as a courtesy and are not guaranteed.

TERMINATION

If a student wishes to discontinue lessons, they may do so at any time by informing Miss Robin. However, payment for the full month is required if any lessons have been taken during the month of discontinuation or termination. Failure to attend lessons does not excuse payment.

Miss Robin's Piano Studio reserves the right to terminate the lessons of any student if the student or a family member acts inappropriately, is excessively absent with no explanation, or if tuition payments are not made on time.

- *After the first lesson, Miss Robin kindly asks that you would make arrangements to wait elsewhere. Miss Robin has other adults (a husband and college-aged daughters) also living in her house and out of respect for their privacy and space, parents will need to spend the lesson time elsewhere.

There are grocery stores, coffee shops, and playgrounds nearby. For Students
